MEMORANDUM OF UNDERSTANDING
Between
Razi University
And
Jiangsu University

Recognizing the importance of academic, research, technological, and cultural cooperation between universities, this agreement is made on November 1st, 2022, between Razi University, a state institution of higher education located at Kermanshah, Islamic Republic of Iran and Jiangsu University located at Zhenjiang, China.

In the spirit of friendship and with mutual interest in cooperation, Razi University and Jiangsu University enter into this Memorandum of Understanding (MOU) to promote joint educational and cultural collaboration and agree as follows:

ARTICLE 1: SCOPE OF COLLABORATION

- 1.1. Either of the institutions can propose potential areas for collaboration, which may include, but are not limited to:
- facilitating the exchange of faculty members and researchers for joint teaching, research, and cultural activities;
 - exchanging students in the areas of mutual interest consistent with regulations of both countries;
 - providing opportunities for faculty members, researchers, and students to participate in conferences, symposia, and international meetings held by either of the universities;
 - collaborating with each other to hold joint scientific, research, technological, and cultural exhibitions and conducting joint research projects;
 - exchanging information, books, scientific publications, scientific and research documents, students' theses, microfilms, and computer software programs in the domains of education, research, technology, and culture;
 - facilitating students' participation in sport competitions held by either of the universities;
 - providing necessary conditions for establishing centers where the official language of the other party's country can be taught in the host university;

- 1.2. Financing any of the above-mentioned activities shall be subject to mutual agreement and the approval of each institution's authorized representatives.

ARTICLE 2: DURATION AND EVALUATION

- 2.1. This MOU shall be in effect for a period of five years from the last date of signature. Either institution may request termination of this agreement in advance, in writing, 60 days prior to the proposed termination date. Any activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed in writing.
- 2.2. A joint evaluation of the MOU will be initiated by the designated representatives 60 days prior to the expiration date. Following the evaluation, the MOU may be renewed and resigned for an additional five years period.
- 2.3. Amendments to this MOU may be requested, in writing, by either party and approved by the authorized signatories.


ARTICLE 3: NON-DISCRIMINATION

The parties agree not to discriminate on the basis of religion, race, creed, national or ethnic origin, sex, age, and disability.

ARTICLE 4: MOU STRUCTURE AND SIGNATURE

This MOU, which contains four articles, was signed in Chinese, Persian, and English versions, all of which are equally authentic and shall come into force upon the signature at both parties. If there is any dispute in interpretation of the MOU, the English version has the priority for interpretation.


